 - Cerumen impaction
 - Ear infections
 - Sinusitis
 - Nasal congestion
 - Allergic rhinitis

- Sore throat
- Perform microscopic examination and cleaning of the ear.
- Be able to diagnose and treat patients age 13 and up.
- Report to supervising physician on a regular basis.
