- Participates in departmental clinical care quality assurance activities
- Maintains continuing medical education and board certification
- Participates in clinical program development
- Participates in the education of Graduate Medical Education trainees as well as faculty development activities recommended by the Academic Intensivist Committee

  - Improving population health/quality/safety
  - Improving efficiency/affordability of health care
  - Improving physician and staff satisfaction and engagement
